

VAWA 2013 Updates

- <u>Tribal Provisions</u>: gave tribal courts jurisdiction to hold non-native offenders accountable
- <u>LGBTQ Provisions</u>: prohibits discrimination to LGBT survivors
- <u>SA Survivors</u>: expands housing protections to SA Survivors in all federally subsidized housing programs, and creates emergency housing transfer options



VAWA 2013 Updates for Immigrant Survivors

- Children included in a U visa victim's application will not "age out" at age 21 and will receive U visas along with their parents
- Add "stalking" to the list of U visa qualifying crimes
- DHS must report annually on VAWA, T, and U visa processing times and waiting time for work authorization
- Public charge exception for VAWA, U and T visa petitioners or holders
- Allow surviving children whose self-petitioning parent died to continue have DHS adjudicate the case and grant self-petitions to the surviving children



VAWA 2013 Updates Continued

- Provides battered immigrants who unknowingly "married" bigamist citizens access to battered spouse waivers
- Strengthened International Marriage Broker Regulation Act (IMBRA)
 - Requires disclosure CPO and violent crime history of sponsoring fiancé/spouse
 - DOJ is responsible for implementing IMB compliance/enforcement system
- Extends Prison Rape Elimination Act (PREA) requirements and protections to all immigration detention facilities run by or under contract or cooperative agreement with DHS and HHS
- Confirms eligibility of crime and trafficking victims who are T or U visa holders in the Commonwealth of the Northern Mariana Island to lawful permanent residency



VAWA 2013 Updates: Underserved

- Underserved populations a key focus and grant making factor in many VAWA funded grant programs
 - "populations who face barriers in accessing and using victim services"
 - Geographic
 - Religion
 - Sexual orientation
 - Gender identity
 - Race
 - Ethnicity
 - Limited English Proficient (LEP)
 - Alienage status
 - Disability
 - Age
 - Any population determined to be underserved by AG or HHS



VAWA 2013 Updates: Population Specific

- Population specific services/organizations –
- 2% set aside of STOP and Arrest grant programs for population specific organizations;
- Authorized purpose in Rural, Youth, Campus, Teen Dating Violence, Health Care and Abuse in Later Life grant programs
 - Expertise + primarily serve members of specific underserved populations
 - Victim centered services
 - Safety
 - Health
 - Economic
 - Legal
 - Immigration
 - Workplace
 - Confidentiality
 - Other victim needs



VAWA 2013 Updates: Culturally Specific

- Culturally specific –
- 10% set aside of each state's STOP grant funds and
- 5% of Arrest, LAV, Rural, Abuse in Later Life and Disabilities grants
 - Limited to racial and ethnic minorities
 - Does not include all immigrants and LEP survivors



VAWA 2013 Updates: STOP

- Training of police, prosecutors and judges can include on U and T visa certification
- Developing and promoting legislation and policies that enhance best practices
- STOP plan consultation and coordination includes representatives from
 - Underserved populations
 - Culturally specific populations
 - Populations specific organizations



VAWA 2013 Updates: Arrest

- Arrest authorized purposes include
 - Encouraging family justice centers to include population specific organizations
 - Developing/strengthening policies, protocols and training for police, prosecutors and judiciary on U and T visa certification
 - Encouraging collaboration with and involvement of population specific organizations in the development and implementation grant funded activities



VAWA 2013 Updates: Civil Rights

- Anti-discrimination provisions –no person shall be
 - Excluded from participation in
 - Denied the benefits of, or
 - Subjected to discrimination
 - By any VAWA grant funded program
 - On the basis of actual or perceived
 - Race, color, religion, sex, gender identity, sexual orientation, disability, or national origin (e.g. LEP)



Trafficking Victims Protection Reauthorization Act (TVPRA) 2013

- Continued presence
 - 15 day response required by federal law enforcement
 - DHS must approve/deny in 1 month
- Report required on
 - # continued presence grants
 - BJA funding for trafficking taskforces
- Federal crime to knowingly destroy, conceal or confiscate for 48+ hours passport, immigration or personal identification documents in certain contexts often indicative of human trafficking



Trafficking Victims Protection Reauthorization Act (TVPRA) 2013

- Block grants to 6 U.S. regions to combat sex trafficking
- Helps unaccompanied children
 - Must be housed in child friendly facilities
 - Screened by DHS officials with child welfare training
 - HHS must be notified within 24 hours of apprehension of any unaccompanied child and be notified when any person in DHS custody claims to be under 18
- Requires states plans on foster care and adoption to include trafficked and sexually exploited children
