Dear Jane,

As you probably already know, U.S. Citizenship & Immigration Services (USCIS) wants to capture your biometric data (usually fingerprints and a photograph) on September 28, 2012 at 8:00 AM at the Application Support Center (ASC) at 1015 Wilshire Boulevard, Los Angeles CA 90017. Please do not miss this appointment; if you do, USCIS may deny your DACA request or delay its processing. If you cannot attend this appointment, please let me know as soon as possible so that we can reschedule it.

When you go to the ASC, please bring your original Form I-797C (a copy is attached) and the best photo ID that you have. A passport or consular ID card is ideal, but a school ID should work as well. USCIS prefers that you bring a nonexpired ID - but if an expired ID is all you have, please bring it with you. Present your Form I-797C and your ID to the ASC employee when you arrive. He or she will review your materials, give you a number and direct you to where you will wait to have your biometrics data taken. This whole process should not take more than an hour or two. When you are done, an ASC employee will stamp your Form I-797C and return it to you. Please bring this stamped Form I-797C to my office the next time we meet.

If USCIS turns you away from the ASC without taking your biometrics, please let me know immediately. I will contact a USCIS supervisor to resolve this problem. Also please note that depending on capacity, USCIS may allow only you - not family or friends – to enter the ASC. Regardless, please exercise caution and do not bring an undocumented person with you into the ASC. Feel free to contact me at (213) 385-2977, extension 157 if you have any questions or if you run into any difficulty at your appointment. Take care.
