Oklahoma (2021)*

- ❖ Total foreign-born population – 230,620
- ❖ 5.8% of the country's ~ 4 million people are foreign born
 - 41.2% naturalized citizens
 - 30% legal permanent residents (as of 2019)
 - 28.8% temporary visa holders or undocumented immigrants
- 75% rise in immigrant population from 2000 to 2021
- ❖ Length of time immigrants have lived in the U.S.
 - 41.5% entered before 1999
 - 28.2% entered 2000 - 2009
 - 30.2% since 2010
- ❖ 14.1% of children under age 18 have one or more immigrant parents
 - 91.4% of these children are native-born U.S. citizens

- ❖ Latin America – 56.8%
 - ❖ Mexico (40.8%)
 - ❖ Other Central America (9.6%)
- ❖ Asia – 25.1%
 - ❖ Southeastern Asia (12.3%)
 - ❖ Eastern Asia (5.9%)
- ❖ Europe – 7.2%
- ❖ Africa – 5.4%
- ❖ Middle East – 2.3%
- ❖ Canada – 1.9%
- ❖ Oceania – 1.2%
- ❖ Language spoken
 - ❖ 10.6% of people in the state who speak a language other than English at home
 - ❖ 47% of foreign-born persons are LEP - speak English less than “very well”

- ❖ Limited English Proficiency (Speak English less than very well)
 - ❖ Naturalized citizens – 34.2%
 - ❖ Noncitizens – 56.1%
- ❖ Limited English Proficiency by language spoken at home
 - ❖ Vietnamese (52.9%)
 - ❖ Chinese (including Mandarin, Cantonese) (48.5%)
 - ❖ Hmong (47.5%)
 - ❖ Spanish (36.9%)
 - ❖ Ilocano, Samoan, Hawaiian, or Other Austronesian Languages (36.2%)
 - ❖ Korean (34.8%)
 - ❖ Tagalog (including Filipino) (33.1%)
 - ❖ French (including Cajun) (28.8%)
 - ❖ Nepali, Marathi, or Other Indic Languages (21.7%)
 - ❖ Russian (21%)
 - ❖ Arabic (20.3%)
