RETROACTIVE CHILD SUPPORT

The Court GRANTS JUDGMENT against Obligor _____ and in favor of ____ in the amount of \$____ with interest at the rate of ____% per annum, for collection and distribution according to law.

The Court finds that retroactive child support should be ordered.

The Court ORDERS obligor, _______ to pay said child support judgment by paying \$50.00 each MONTH beginning the _____ day of _____, 200__, payable on or before that date and on or before the same day(s) of each MONTH thereafter until Obligor's regular child support obligation ends or until he has paid the judgment in full. If Obligor's has not paid the judgment in full by the date his regular child support obligation ends, the Court ORDERS obligor to pay the remainder of said judgment by paying \$50.00 each MONTH on or before the same day(s) of each MONTH until he has paid the judgment in full. The withholding order authorized herein shall include such payments, but nothing herein shall prohibit the use of other collection methods authorized by law.

Child Support Findings

The Court finds that on January 26, 2001, Judge ______ ordered Respondent to make periodic payments of child support, which ordered in relevant part that Respondent pay the sum of \$541.77 per month beginning February 1, 2001, and on the first of each month thereafter for child support.

The Court further finds that Respondent has failed to make payments as ordered. The Court further finds and confirms that Respondent is in arrears in the amount of \$13,711.33 for the period from February 1, 2001 through June 18, 2003 and that prejudgment interest has accrued in the amount of \$822.68. Judgment should be awarded against Petitioner in the total

amount of \$14,534.01 for the arrearages and prejudgment interest.

Relief Granted

Judgment

IT IS ORDERED AND DECREED that Petitioner,, is granted judgment
for child-support arrearages, including any accrued interest, against Respondent,, in
the amount of \$14,534.01, such judgment bearing interest at 6 percent simple interest per year
from the date this order is signed, for which let execution issue.
The Court ORDERS Respondent,, to pay said child support arrearage by
paying \$100.00 each month beginning on the 1st day of July, 2003, payable on or before that
date and on or before the same day of each month thereafter until Obligor's regular child support
obligation ends or until has paid said arrearage in full. If Obligor has not paid
the judgment in full by the date's regular child support obligation ends, the
Court ORDERS Obligor to pay the remainder of said judgment by paying \$541.77 each month
on or before the same day of each month until has paid the arrearage in full. The
withholding order authorized herein shall include such payments, but nothing herein shall
prohibit the use of other collection methods authorized by law.

A child support obligation does not terminate on the death of the obligee but continues as an obligation to the child named in the support order.
