RM 00202.142 Form SS-5 Item 8.B. — Mother's SSN

A. POLICY - ENTERING THE MOTHER'S SSN

An entry in item 8.B. reflects the mother's SSN when provided by the applicant. An entry is required on applications for original SSN cards for children unless the applicant has a valid reason for not providing the mother's SSN.

B. POLICY - VALID REASON FOR NOT PROVIDING MOTHER'S SSN

Valid reasons for not providing the mother's SSN are as follows:

- The mother does not have an SSN.
- **REMINDER:** Needing an SSN for an IRS tax purpose is not a valid reason to assign an SSN. Refer the alien to IRS to obtain an Individual Taxpayer Identification Number (ITIN) for tax purposes. Do not show the mother's ITIN on the SS-5.
- The mother's SSN is unknown, the applicant is other than the mother and the applicant cannot be reasonably expected to obtain the SSN. (For example, the child is in State custody for foster care or has been given up for adoption.).

C. PROCEDURE - OBTAINING MISSING SSN

Follow the procedures below to develop for the mother's SSN.

NOTE: See <u>RM 00202.147C.</u> if the father's SSN is also missing.

1. Application received by mail

a. Applicant is mother

- If all evidence needed to process the application was provided but the mother's SSN is missing, first try to obtain it by telephone. If obtained, enter it in item 8.B. and annotate as an "FO WRITE-IN".
- If unable to reach the mother by telephone, return the application and evidence with Form SSA-795 using Exhibit A language (RM 00202.142F.) to request that she include her SSN on the SS-5. (Destroy the SSA-795 if a decision is subsequently made to process the SS-5.)
- If the mother has a valid reason per <u>RM 00202.142B</u>, for not providing her SSN, write the words "NO SSN" or "UNKNOWN", as appropriate, and annotate as an "FO WRITE-IN".
- If the mother is unwilling to provide her own SSN or sufficient identifying information for SSA to clearly identify her assigned SSN, follow <u>RM</u> 00202.142D.

b. Applicant is other than mother

- If all evidence needed to process the application was provided but the mother's SSN is missing, first try to obtain the missing SSN by telephone. If obtained, enter it in item 8.B. and annotate as an "FO WRITE-IN".
- If unable to reach the applicant by telephone, return the application and evidence with Form SSA-795 using Exhibit B language (RM 00202.142G.) to request that the mother's SSN be included on the SS-5. (Destroy the SSA-795 if a decision is subsequently made to process the SS-5.)
- If the applicant has a valid reason per <u>RM 00202.142B</u>, for not providing the mother's SSN, write the words "NO SSN" or "UNKNOWN", as appropriate, and annotate as an "FO WRITE-IN".
- If the applicant knows the mother's SSN but is unwilling to provide it, follow <u>RM</u> 00202.142D.

2. Application taken in person at FO

a. Applicant is mother

- If the mother does not know her own SSN, ask for complete identifying information to do an alpha-search for her SSN.
- If the mother has a valid reason per <u>RM 00202.142B.</u> for not providing her SSN, write the words "NO SSN" or "UNKNOWN", as appropriate, and annotate as an "FO WRITE-IN".

b. Applicant is other than mother

- DO NOT conduct an alpha-search for the mother's SSN.
- If the applicant has a valid reason for not providing the mother's SSN per <u>RM 00202.142B.</u>, write the words "NO SSN" or "UNKNOWN", as appropriate, and annotate as an "FO WRITE-IN".
- If the applicant knows the mother's SSN but is unwilling to provide it, follow RM 00202.142D.

D. PROCEDURE - UNWILLINGNESS TO PROVIDE MOTHER'S SSN

Provide the applicant with written notice per RM 00204.330explaining why no SSN can be assigned to the child if:

- The applicant is the mother and is unwilling to provide her own SSN or sufficient identifying information for SSA to clearly identify her assigned SSN.
- The applicant is other than the mother but knows the mother's SSN and is unwilling to provide it.

REMINDER: Per RM 00204.330B.3. FOs do not need to retain any material when an SSN cannot be assigned. The SS-5 and r elated material are returned to the applicant with the appropriate written notice explaining why no SSN can be assigned.

E. PROCEDURE - ENTERING THE MOTHER'S SSN IN ITEM 8.B.

1. Initial Entry

- Enter the mother's nine-digit SSN as initially provided by the applicant or as provided after the additional development described in RM 00202.142C.
- If the mother does not have an SSN or the mother's SSN is unknown, write the words "NO SSN" or "UNKNOWN", as appropriate, and annotate as an "FO WRITE-IN".
- Key the paper SS-5 into MES using the non-interview mode.

2. SSN Does Not Verify - Additional Actions

Since the applicant will not be present, proceed as follows when the enumeration feedback message indicates the SSN does not verify:

- Try to obtain the correct SSN from the applicant by telephone. If obtained, enter it in item 8.B. and identify as an "FO WRITE-IN".
- If unable to reach the applicant by telephone, return the application and evidence with Form SSA-795 using Exhibit A or Exhibit B language, as appropriate, (RM 00202.142F. or RM 00202.142G.) to request that the mother's correct SSN be included on the SS-5. (Destroy the SSA-795 if a decision is made to process the SS-5.)
- **Do not process the SS-5** but provide the applicant with written notice per RM 00204.330 explaining why no SSN can be assigned to the child if:
 - the applicant is the mother and is unwilling to provide her own SSN or sufficient identifying information for SSA to clearly identify her assigned SSN, or
 - o the applicant is other than the mother but knows the mother's SSN and is unwilling to provide it.
- Continue to process the SS-5 even though the mother's SSN does not verify if the applicant is other than the mother and the response shows there is a valid reason per RM 00202.142B. for not providing the mother's SSN.
