Challenges for Attorneys

- Ensuring access to courts and legal aid for victims
- Custody challenges
- Rapidly changing court procedures
- Compliance with visitation agreements and/or the mutually agreed upon temporary modifications to court ordered agreements

Challenges for Victims

- Tech issues
- No access to printers and scanners
- Childcare for victims that still need to work
- Non-custodial parents making threats regarding the visits, sometimes even if there is an agreement or communication between counsel to address COVID-19 concerns
- Being forced to compromise



Social Distancing Strategies

- Online/Phone intake
- Email draft pleadings to clients
- Designate drop-off box for completed forms
- Virtual visitations
- Telephonic meetings with clients
 - Zoom (be aware of safety measures)
 - FaceTime; Skype; WhatsApp; Facebook



Social Distancing Strategies: Courts

- Ability to file from home via email or phone
- Hearings via phone
- Obtain emergency protection orders via phone or video with judge remotely
- Email or call for protection order extensions

Immigration Advocacy Asks to USCIS

- Automatically extend survivor status and Employment Authorization
- Uniformly and Automatically Extend Deadlines for responding
 - Requests for Evidence (RFE)
 - Notices of Intent to Deny (NOID)
 - Notices of Intent to Revoke (NOIR)
- Suspend issuance of NTAs
- Suspend filing deadlines for Appeals and Motions to Reopen Reconsider
- Expedite all survivor-based applications for survivors who are detained
- Allow for the Submission of Digital Signatures (Certifications and handwritten software)



Cont. Immigration Advocacy Asks

- Toll, as of March 11, all survivor Age-Out cases and derivatives of self-petitioners, U visa, U visa adjustment, and T visa
- Suspend the two-year deadlines for VAWA selfpetitioners whose abusers die or from whom they divorce
- Allow Initial Evidence to be Submitted After Filing
- Suspend expiration of signed LEA Certifications
- Ensure acceptance of any credible evidence in support of Fee Waiver Applications
