

That inquiry is conducted under the supervision of the court, and a great deal must, of necessity, be left to its sound discretion.

Connors v. United States, 158 U.S. 408, 15 S. Ct. 951, 39 L. Ed. 1033 (1895)



#### Caveat

- Jury selection differs vastly between jurisdictions, courtrooms, and judges
- NIWAP and subject-matter experts are available for case-specific assistance
- Consider how to adapt strategies within the confines of your courtroom

# Analyze Case

## Victim Selection

 Did the offender choose the victim because of a real or perceived vulnerability?

# Criminal Act

• Did the offender use the victim's immigration status to commit a criminal act?

# Escape Detection

 Was the victim prevented from reporting the crime to police because of their immigration status?



# Goals of Jury Selection

Educate

Uncover biases

Establish trust

Manage expectations

Demonstrate Leadership Instill Empathy



#### Educate

- Legal concepts related to domestic violence, stalking, or sexual violence
- Predatory nature of offenders
- Victim behaviors
- Immigration relief



# Manage Expectations

- Victim may not have immediately reported the crime
- Victim may be undocumented
- Victim may have engaged in criminal behavior
- Offender may not have used violence, but merely threats of violence or deportation



# Instill Empathy

- Humanize the victim
- Discuss vulnerabilities
- Use jurors to discuss their experiences with domestic violence, stalking, and sexual assault
- Explore what the "American dream" means



# It is not required... that the jurors be totally ignorant of the facts and issues involved.

<u>Irvin v. Dowd</u>, 366 U.S. 717, 81 S. Ct. 1639, 6 L. Ed. 2d 751 (1961)



#### **Uncover Biases**

Will the juror be able to "get" ...

- Victim is not on trial
- Predatory nature of offenders
- Equal protection of the law for immigrant victims
- Intent of immigration relief for victims of crime



#### Establish Trust

- Be accurate about the law
- Do not hide "bad facts"
- Be respectful to the judge, defense attorney, defendant, court staff, and jurors
- Establish yourself as the authority in the courtroom



# Leadership

- Inspire jurors
- Be authentic and genuine
- Do not be repetitive
- Use appropriate humor
- Demonstrate professionalism
- Be prepared



Without an adequate voir dire the trial judge's responsibility to remove prospective jurors who will not be able impartially to follow the court's instructions and evaluate the evidence cannot be fulfilled.
