

#### **Common Misconceptions**

- "She only wants the CPO to get immigration status."
- "He should get custody of the children because he is a citizen and she'll just take the kids to another country."
- "I'm afraid to call the police; if I do I will be deported."
- "She just made up the sexual assault charge to get a visa."

A directory of service providers with experience working with immigrant victims of domestic violence, sexual assault. U-visa crimes and human trafficking, by state, If you are an individual or organization working with immigrant survivors, please make sure that your contact information is correctly represented within the directory.

Use the following link to search for service providers in your state. This directory is also useful to identify organizations in another state to which an immigrant victim may be considering moving. If you are working with an immigrant victim for whom you need resource materials on immigrant victims legal rights or you need a referral to another jurisdiction to a program that has staff or volunteers who speak the victim's language you can search this data base by language to identify such programs.

We recommend that you start your search with wider terms, such as state, city or language, and look for more specific options within these searches: Directory of Service Providers
