## **DOCUMENTS IN SUPPORT OF GOOD FAITH MARRIAGE**

To qualify for a VAWA self-petition, it is important to prove that the marriage was entered into in "good faith", or for love, not for the purpose of receiving immigration benefits.

The requested evidence listed will strengthen showing of good faith marriage to support your written declaration.
